Guidelines for Submitting a Presentation Proposal

1. Complete the proposal form, on the last page, and email it to the Program Chairman, Michael Johnson at: program@behavioralsafetynow.com
2. The Title and Summary, if the proposal is accepted, will be posted on the Conference web site. Please ensure therefore that:

The title: Is brief, yet clear. (Please do not add a sub-title.)

The summary: Should clearly state:

- (1) The purpose of your presentation;
- (2) The main message and ideas that you will be presenting;
- (3) What the participants will learn.

3. The Program Chairman (Michael Johnson) will notify those whose submissions have been accepted no later than July 1st 2010.
4. At the time of acceptance, you will be requested to email a brief, up-to-date, biography and, if possible, a photograph (electronic format - 150 dpi - .tif or .jpg format - Please do not send pictures in word or .pdf format.) to accompany your presentation information. This information will be posted on the conference website.
5. Presenters who register before June 13th 2010 will receive the reduced conference registration rate of \$430 (higher rates will apply after June 13th. Regular registration is \$480 from June 14th-September 12th. Late registration is \$510 from September 13th-October 10th. On-site registration is \$530 – see conference website for registration information and deadlines.). Consultants should please note: in order to be considered as a presenter, exhibitor, or cosponsor of the conference, you must satisfy the following criteria.

A consultant must either:

- be a full member of the Association for Behavior Analysis or meet the eligibility requirements, or
- work for an organization with a principal who is a full member or meets the eligibility requirements

These eligibility requirements are a Master's degree in experimental or applied behavior analysis, or significant contributions to the field of behavior analysis.

The Master's degree must include either:

- a minimum of one year's supervised experience in behavior analysis and a graduate project, thesis or dissertation in behavior analysis, or
- two or more years supervised experience in behavior analysis.

Significant contributions to knowledge in behavior analysis must be documented by research publications, presentations at professional conferences or other comparable means reflected in a vita.
